Over the past four years, she has chaired the 4th of July and Sing and Sleigh events, redesigned the Web site, initiated the e-mail list, managed the dues payer database, set UPCC up on PayPal, and she distributes graffiti supplies to all. Most recently, she has worked on the Ribbon Cutting Event for the reopening of Observatory Park playground. Dana got involved with the UPCC because she wanted to be part of the community, and she believes the UPCC can help foster community for her family and neighborhood.

# A 'Grand' Reopening!

Over a year ago, the neighborhood began working with Denver City Parks and Recreation to renovate the Observatory Park playground. It had been over 20 years since the last playground was installed. Today, there is a new, much loved playground. To celebrate, the University Park neighborhood held a Grand Reopening potluck and party at the park.

Over 250 neighbors were in attendance. Tiny infants, toddlers, teens, pregnant moms, empty nesters, and seniors — some who grew up in University Park and saw the original playground constructed — all reveled in the sights and sounds of kids playing

on the new playground.

The event included a neighborhood potluck, a generous donation from Anthony's Pizza, a pumper truck and firemen from Fire Station 24, representatives from Denver Police District 3, and bubble play by The Bubble Project. The new Community Toy Bin was unveiled.

At one point, over 50 children ran through a 25-foot banner that said "Thank you for our playground." Members of University Park Mothers Club, University Park Community Council, and the office of our City Councilman, Charlie Brown, made the event possible.

## HAPPENINGS AT UNIVERSITY PARK ELEMENTARY SCHOOL

We thank our entire community for support of this year's Home Tour on May 2. We raised \$29,000 to hire extra teachers and to purchase books and computer software, among other items for the school.

On April 21, in observance of Earth Day, Sara Davis of the Mile High Million Tree Initiative helped both of our fifth grade classes plant a tree on the school grounds. Our tree is number 182,444 toward the City of Denver's goal to plant one million new trees.

This is also the third year UP Elementary will tend the Friendship Garden. Our students have tilled the soil and planted. We will be serving samples of our harvest in the school cafeteria and hosting a Youth Farmers Market this fall. Donations of neighborhood garden produce and flowers for the market would be most appreciated.
